

JOINT BOARD PRESIDENT & EXECUTIVE DIRECTOR'S REPORT

We are pleased to present the eleventh annual report of North Eastern Ontario Family and Children's Services (NEOFACS)

As we pause to reflect on the past year and look ahead to the future, we are filled with pride in sharing the remarkable journey of NEOFACS.

Throughout the 2022-2023 fiscal year, our dedicated team of professionals has tirelessly strived to elevate the quality of services we offer. With a profound dedication to our mission, we are excited to announce significant strides in advancing our strategic priorities.

The past year, we marked NEOFACS' 10th anniversary. Over the past decade, NEOFACS has grown and evolved while staying steadfast to our mission of safeguarding and enhancing the well-being of children, youth, and families in our communities. We have reached numerous milestones, including developing new programs and services, expanding partnerships, and growing our dedicated team of professionals. We take pride in these accomplishments and eagerly anticipate the future, where we can continue positively impacting the lives of those we serve.

As we emerge from the shadow of the pandemic, we recognize the paramount importance of children's and youth's health and well-being. The pandemic has profoundly affected their mental and physical health, prompting us to deliver programs and services that address their unique needs during these trying times.

We are proud to share that NEOFACS' Child and Youth Mental Health services have joined the provincial One Stop Talk/Parlons maintenant (OST/PM) program, offering free virtual walk-

in counselling services to children, youth, and their families in our community. Launched in November 2022, this program successfully entered phase 2 in March 2023, with NEOFACS actively participating. The ultimate goal of OST/ PM is to create a comprehensive mental health system that ensures Children and Youth in Ontario receive the right level of service when and where they need it.

This year, we are also delighted to introduce the Ready, Set, Go (RSG) program for applicable youth involved in Child Welfare. This provincial initiative is designed to support young people transitioning from care to adulthood. Our organization recognizes the significance of providing ongoing support to these young individuals, and we are deeply committed to ensuring they have access to the resources and assistance needed to succeed. We eagerly embrace the Ready, Set, Go program and look forward to engaging with young people until their 23rd birthday.

After much advocacy, NEOFACS has received nearly \$2 million from the federal and provincial governments to create six supportive housing units in our building at 457 Wilcox Street in Timmins. The one-storey building will be retrofitted to include four one-bedroom apartments, a barrier-free/accessible onebedroom apartment and a three-bedroom unit for the House Parents. The program will provide youth receiving services from NEOFACS access to safe, supportive housing as they transition to adulthood.

NEOFACS joined several Children's Aid Societies across Ontario in conducting a comprehensive staff census. This census collected experiencebased and identity-based information from our dedicated staff, focusing on inclusion, safety, and belonging. The insights gathered through this census will be a foundation for evidenceinformed decision-making, supporting workplace inclusion and equity initiatives. By collecting this valuable information, we aim to better understand our employees' individualities, needs, and challenges, ultimately aiding us in crafting future workforce planning and employment equity strategies.

After a year-long pilot, NEOFACS has decided to make the hybrid/remote workplace model a permanent part of our operations. This decision, informed by lessons learned during the pandemic, consultations with our employees, and a focus on client-centred decision-making and innovation, reflects our commitment to employee well-being and efficiency. We anticipate this change will positively impact our service delivery.

Again, this year, we were delighted to collaborate in organizing Mental Health Week activities in multiple communities. These initiatives have helped foster a sense of community and raise awareness about mental health. Notably, this year, our New Mentality groups transformed our Kapuskasing, Timmins, and Kirkland Lake offices into welcoming spaces for children and youth. We hope to expand the program into all NEOFACS buildings.

We are pleased to announce that the Ministry of Health has approved two new Ontario Health Teams (OHT) for our catchment area. One OHT is in the Cochrane District, while the second is in the Timiskaming District. These OHTs will bring together healthcare providers from various sectors to better coordinate care and planning. Through this transformation, NEOFACS is a core member of both OHTs and will strongly advocate for children's and youth's mental health.

We sincerely thank our dedicated workforce, governors, kinship caregivers, foster parents, adoptive parents, and invaluable volunteers. Their unwavering dedication and tireless efforts enable us to continue providing highquality services to North Eastern Ontario's children, youth, and families. Our staff are our most cherished assets, and we are deeply thankful for their commitment. We also acknowledge the vital contributions of our kinship caregivers, foster parents, and adoptive parents, who open their hearts and homes to vulnerable children and youth, setting a truly inspiring example. Our dedicated volunteers enrich our services and positively impact the lives of those we serve. We are grateful for their support and look forward to continued collaboration in pursuing our shared goals.

Lastly, the Board and Agency extend their best wishes to outgoing Board Members Dennis Draves and Barry Gaunt, acknowledging their significant dedication and commitment to the Agency and our community's children, youth and families.

OUR OPERATIONAL PLAN 2022-2023

To achieve the long-term goals and objectives in our Strategic Plan 2022-2027, we developed a comprehensive yearly operational plan that outlines the specific actions and initiatives we undertook through daily activities.

Our Operational Plan for 2022-2023 included defined responsibilities and timelines to ensure that we stayed on track and achieved our strategic objectives in a timely and efficient manner.

The plan identified 33 actions to support the strategic directions and related goals. Significant progress has been made, and we have achieved effective results.

Each action had several related activities, with most supporting multiple Strategic Directions:

- **11 of 33 actions** supported all three Strategic Directions
- **17 of 33 actions** supported two of the Strategic Directions
- **5 of 33 actions** supported a single Strategic Direction

Out of the 33 actions, the following has been accomplished from April 1, 2022 to March 31, 2023:

- **12 actions** are fully complete
- 10 actions are 75%+ complete
- 7 actions are 50%+ complete
- Only 4 actions are less than 50% complete

Highlights of the initiatives we succeeded in accomplishing:

Transition Home Program

We advocated to secure funding for a Transition Home Program in Timmins for youth aged 16 to 23. We had a successful visit from the Honourable Michael Tibollo, Ontario's Associate Minister of Mental Health and Addictions, and the Honourable George Pirie, the Member of Provincial Parliament for Timmins, to our Wilcox site in January of 2023. During their visit, we had the opportunity to discuss the needs of our community and our proposed plans for creating a semi-independent transitional housing program on-site for youth in the region.

Employee Wellness

We offered ongoing wellness activities to employees per the Wellness Committee's work plan, focusing on physical and mental wellness, including Summer Get Moving Challenge, Fabulous Fall Photo Submission, Desk Stretches Session, Christmas Spirit Week Activities, and Virtual Yoga Series.

Employee Inclusion

In Fall 2022, we joined several Children's Aid Societies across Ontario to gather experience-

NEOFACS collaborated with independent research firm Metrics@Work to implement the Staff Census. The objective was to gather experience-based and identity-based information to promote workplace inclusion and equity. The census results and staff demographic data will be utilized to make informed decisions and support initiatives that foster these values in the workplace.

Service Philosophy

We defined a Service Philosophy that clearly articulates client service experience expectations (See page 5). Youth consultation was included in the process.

Policies and Procedures

We conducted a comprehensive review of all policies and procedures for content and organization in anticipation of moving to PowerDMS, a new cloud-based policy management solution.

Equity, Diversity, and Inclusion (EDI)

We further reviewed all policies and procedures

We provided orientation to Equity, Diversity, and Inclusion (EDI) and shared Truth and Reconciliation Commitments with all employees and Board members.

We further reviewed all policies and procedures for content and applicability related to EDI.

Additionally, we provided all employees and Board members with an orientation on EDI and shared our Truth and Reconciliation Commitments with them.

New Employee Orientation and Recruitment Strategies

We have developed mechanisms for the ongoing orientation of new employees through onboarding processes.

We have begun creating targeted recruitment strategies for employees, board members, kinship care and foster care providers, and volunteers.

Work Plan Implementation

We implemented all 2022-23 priorities identified in the Signs of Safety (SofS) work plan, Moving on Mental Health (MOMH) Multi-Year Plan, and

Youth and Family Engagement work plan.

We also fully implemented the priorities identified in the French Language Services (FLS) Committee work plan, which included mandatory Active Offer training for employees to support offering quality services.

Client Feedback Mechanism

We developed and implemented a client feedback mechanism for all services in November 2022. This project reflects our goal to nurture and strengthen feedback mechanisms for children, youth, and families. The surveys are open to clients receiving service from NEOFACS in our Child Welfare, Child and Youth Mental Health, Youth Justice, and Prevention programs. The survey answers are anonymous, confidential, and voluntary. We will use the feedback to better understand what we are doing well and, most importantly, how to improve our services.

In addition to the contest, we sponsored free public skating at community rinks throughout the region during March Break 2023, providing a fun activity for children, youth, and families to enjoy together!



SERVICE UPDATES: WHAT'S NEW AT NEOFACS

Signs of Safety Implementation Updates for Child Welfare Services

NEOFACS has remained committed to implementing the Signs of Safety[®] (SofS) practice framework in our child welfare services throughout 2022-2023.

Our focus has been on improving the safety and well-being of children, youth, and families. We have incorporated a culture of Appreciative Inquiry and have applied the core principles of SofS through the lens of equity, diversity, and inclusion. We also committed to offering Trauma-Informed



Practice training to provide employees with a broader understanding of the impact of trauma on clients.

Our successful implementation of Signs of Safety has been achieved through family and support network engagement, strength-based safety planning and mapping, Appreciative Inquiry in day-to-day casework, group supervision, and using Words and Pictures/My Three Houses tools.

Program Delivery Updates for Child and Youth Mental Health Services

In April 2022:

The Agency began its onboarding process to join other Child and Youth Mental Health (CYMH) provincial agencies in offering the One Stop Talk/Parlons maintenant (OST) program. Two registered clinicians and their respective program supervisors were trained, and we began offering this service in March 2023. OST offers children, youth (within 18 years of age), and their families immediate access to free mental health support. The program provides single session counselling support and ensures direct referral to additional services when needed. Learn more about the program at www.neofacs.org/one-stop-talk

In May 2022:


The Agency began its journey to offer PreVenture, an effective, evidence-based program that promotes mental health and delays substance use among teens 12-18. The program will help youth learn coping skills, set long-term goals and channel their personality towards achieving them. Over 40 employees from our Counselling and Therapy Services, F.W. Schumacher Live-In Treatment Program, Youth Transition Program, Non-Residential Attendance Centres and Restorative Justice Program were trained along with over 11 administrators. Trained workers are set to start offering PreVenture to their assigned clients in June 2023.

In June 2022:

The Agency successfully secured \$6,000 in sponsorship funding from Bell Let's Talk. The funding is for a pilot project to redecorate three client meeting rooms in Kapuskasing, Kirkland Lake, and Timmins. The idea for this project was suggested by youth from The New Mentality groups who expressed the need for more child/youth-friendly, inviting, unique and comfortable spaces. The youth from The New Mentality groups and their staff allies have been leading the planning and execution of the new room designs, with a completion date of May 2023.

In December 2022:

The Agency received \$15,000 from the Knowledge Institute on Child and Youth Mental Health and Addictions to further our youth and family engagement initiatives. The Youth/Family Engagement Core Team, comprised of Agency staff and management, is busy working with our Youth Advisory Committee (YAC), The New Mentality, and student volunteer groups to further support and implement youth and family engagement opportunities.



• The Voluntary Youth Services Agreement (VYSA) is available for 16- and 17-year-olds who require an out-of-home placement, which gives them a better opportunity to get the support they need, and have better outcomes as they transition to adulthood.



• The Continue Care and Support for Youth (CCSY) aims to help youth who are 18 and transitioning from care to adulthood live independently and access counselling and other supports and programs.







Bursary Awards Program:


In 2022, a total of **\$10,899** in awards, bursaries and endowments were awarded to **13 deserving youth**.
